Part 2: Description

Overview: This module explores the uses of history in the public domain, from museums and heritage sites, to historical broadcast media, re-enactment, and community projects.

Features: Not applicable

Educational aims: In this module, students will explore the varied ways in which historical knowledge is shared with public audiences, examining its uses and value in

the present and in shaping futures. Critically engaging with public history will support students to articulate their skills as historians and consider the application of their subject knowledge and skills in a range of creative and professional contexts outside of university.

Outline syllabus: Students will choose two subject areas through which they will explore approaches, issues and debates concerning the ways in which histories related to that area have been shared with public audiences.

Students will focus on public history in British, European, and Global contexts. They will have the opportunity to engage in field work, and with our network of external professional partners. There will also be the opportunity to explore the module themes in an international field trip.

Part 3: Teaching and learning methods

Teaching and learning methods: Teaching and learning will be delivered through a combination of lectures, workshops, personal tutorials, and field work. Students will choose to participate in two subject strands out of three options, with each strand delivered by a member of the teaching team according to their specialism. For each subject strand, students will have 3 hours of contact time per week.

Having practiced critical reading and reflection in their reflective report at Level 4, students will be ready to apply this approach to weekly preparation tasks for taught sessions at Level 5.

Student learning will be supported on the VLE, where reading lists, weekly preparation materials, and teaching slides are posted. Students can also access a detailed assessment brief from the start of teaching and will be offered personalised assessment advice during scheduled teaching time.

Part 4: Assessment

Assessment strategy: Assessment will consist of a portfolio of work comprising two tasks reflecting each subject strand chosen by the student. In each task, students will explore and critically reflect on how history is communicated to diverse audiences, and make their own contribution to public-facing work.

The two portfolio tasks will be chosen to support appropriate, inclusive and effective engagement with the subject strand content; to support students to explore each topic in depth; and to enable students to communicate their critical reflections in different ways allowing them to demonstrate their strengths and develop new skills.

Tasks will enable students to analyse and evaluate different forms of public history,

and to communicate their critical reflections in written tasks, visual, and/or oral

outputs. Students will also be supported to reflect on their own research and

practice.

Formative assessment: in advance of the final deadline, students will be invited to

attend assessment consultations to discuss and refine their plans for completing the

tasks.

Portfolio assessment guidelines will be included in the module handbook, setting out

the principles and parameters of the portfolio and portfolio tasks to ensure parity and

cohesion across subject strands and modules.
