Part 3: Teaching and learning methods

Teaching and learning methods: Lectures will provide contexts, key ideas and approaches that underpin the longer, practical workshop sessions. In workshops students will have the opportunity to discuss relevant critical literature in depth, as well as interrogating a range of related archival evidence. Both the content-led and practical elements support students to complete the module assessment.

Part 4: Assessment

Assessment strategy: For the document analysis, students will select and analyse a primary text related to one of the topics addressed, drawing out its significance in relation to the central themes of the module. This exercise tests students' abilities to construct an argument and engage directly with primary evidence and the relevant historiography.

The visual source study is designed to assess the ability of students to engage in independent primary research that addresses the central issues of the module, and the communication of their research in visual and textual forms.

The assessment broadens their experience and confidence in locating, selecting, and interpreting a range of evidence, and communicating their research and critical analysis, supporting more extensive independent research projects at Level 6.
