Part 2: Description

Overview: Politics, States, and Resistance introduces ideas, concepts, and issues, focusing on state institutions and resistance through empirical approaches central to the study of politics.

Educational aims: The module introduces students to core ideas, concepts, and analytical frameworks, fostering an understanding of power relations in a range of

Students will engage with a range of topics such as the structure of the state and the operation of political institutions as well as how these structures are challenged and changed. Through this, the module develops critical thinking skills, empowering students to question assumptions and construct reasoned arguments. Ultimately, it prepares learners to participate in informed political discourse and contribute to democratic processes and societal change.

Outline syllabus: The module offers an exploration of key political concepts, ideas, and practices. Students will engage with foundational ideas such as the state, power, democracy, and legitimacy, examining how these concepts shape political structures and societal organization. The module also delves into the politics of resistance, exploring how movements and actors challenge authority and create change. Key topics may include forms of government, political institutions, civil society, and dissent and repression. The interplay of power, ideology, nationalism, globalization, democracy, and authoritarianism in shaping political systems and resistance is examined, with real-world applications provided through cross-country case studies. This approach equips students with the tools to analyse and understand the nature of state authority and how it can be challenged.

Part 3: Teaching and learning methods

Teaching and learning methods: The module will mix lecture content and seminar activities, typically in a lectorial format, to allow students to both learn about, and actively participate in, issues related to governance and the challenges to it. Students will be encouraged to actively participate in the learning process by contributing ideas, questions, and critical standpoints. The learning environment is designed to promote peer-to-peer support and exchange, providing students with a critical perspective on politics and contestation.

Part 4: Assessment

Assessment strategy: Task 1 – Written Assignment (1500 words).

Students will write a 1500 word assignment that directly engages with literature related to the material covered in the first part of the module. This task is intended to develop students' ability to assess the strengths and weaknesses of academic literature, and to do so in a way that goes beyond generative AI summaries. This may involve a range of approaches (as will be detailed on the assessment brief) such as considering the quality of evidence that the author(s) put forward, and/or reviewing the strengths and weaknesses (limitations) of the position the author argues.

Task 2 – Choice of Assessment (1500 word written assignment or 10 minute presentation).

This assessment requires students to draw on relevant case studies and debates

Page 4 of 6 11 February 2025 covered in the module in the format of a set task that will be able to be delivered in either a written or oral format (this will be detailed on the assessment brief so students have a clear idea of what format best suits them, and the choice will be theirs). Students will explore a historic or contemporary case study of resistance and apply relevant concepts and debates covered in the module. This may be combined with reflections on the student's learning and understanding of goals and actions of various political actors.
