Part 2: Description

Overview: This module will build upon the knowledge and skills acquired in the level 5 module, Occupational Competencies: Professional Policing and incorporate some of the Craft Skills: Ethics and Communities learning outcomes and provides learning opportunities that are more interconnected and applicable to the learner's operational duties.

As learners' progress through the module, they will learn skills that can support

decision making and problem solving in crime prevention/reduction strategy.

In the skills of investigative practice, learners will develop their knowledge in the use of intelligence gathering and analysis and consider any additional requirements to complex crime investigations. This will be extended to learning in both the national and international investigation context.

Features: Not applicable

Educational aims: Building upon their learning in the first two years and their continued operational development, this module will focus on the five strands of policing; Response Policing, Roads Policing, Neighbourhood and Community Policing, Information and Intelligence; and Conducting Investigations.

Learners will draw on evidence from their Occupational Competency Portfolio (OCP). They will identify and reflect on areas where they have already developed their knowledge, skills and behaviours, focusing on relevant legislation and professional standards and will show how they intend to sustain and drive their continued professional development (CPD) in the future.

Outline syllabus: The syllabus has been mapped to the College of Policing PCER curriculum and is continuously amended as the curriculum is revised.

Learners will continue to develop their critical thinking skills, adopting contemporary models and modes of working as they work towards the End Point Assessment. They will be given the opportunity to broaden their critical understanding of offenders, victims and the agencies to which they partner, develop their skills and knowledge towards achieving greater operational competency.

They will also have the opportunity to gain a greater insight into the process of accountability, feel empowered to challenge issues of unethical attitudes and practices that do not align with the ethical principles of policing practice.
