## Part 2: Description

**Overview:** This module focuses on supporting students to critically explore the socio-political context of community nursing and to investigate the ways in which wider health and social care policies shape practice, and how nurses can influence and inform policy.

Students will be expected to engage with the research evidence in relation to a number of key policy issues and critically analyse and evaluate their application to

District Nursing.

The module will explore a range of policy areas to develop the students' knowledge and understanding. To support students, the module will commence with an overview of Evidenced Based Practice, focusing on research methods and methodologies.

**Educational aims:** This module is part of the Specialist Practice District Nursing Programme and has been aligned to the NMC Standards of proficiency for community nursing specialist practice qualifications (SPQ) and Standards for post-registration programmes.

The aim of the module is to develop students' ability to critically analyse and evaluate the socio-political context of District Nursing and identify the implications for community nursing services and patient care. To achieve this, students will demonstrate confidence and ability in critical appraisal, analysis and evaluation of health and social care policies and research evidence within the context of District Nursing.

**Outline syllabus:** The syllabus would typically include:

Understanding Evidenced Based Practice / Research Methods and Methodologies:

Exploration of key research methods and methodologies used in health and social care.

Critical appraisal

Political Leadership:

Exploring nursing's place within the policy (macro and micro) making arena.

Factors affecting their influence and contribution at a strategic level. \*

Strategies to promote involvement. Articulating the value of the nursing contribution to influence change and action.

Public Health:

Principles of public health applied to District Nursing practice

Health Inequalities

Opportunities and barriers to a PH approach in District Nursing

Genomics as applied to DN practice.

Leading, supporting and managing care:

Caseload management and coordinating complex care

Ethical decision-making reflecting equality, diversity and inclusion

Leading safe and equitable care

Integrated practice:

Concepts of integration: underpinning values / approaches

Impact of current health and social care policy on integrative practice

Effective working across integrated care systems and multiagency networks

Service user and carer involvement:

Concepts of partnership and co-production as they relate to person centred care.

Critical examination of policy underpinning SUCI. Evaluation of research evidence in relation to (community) nursing? To what extent is this embedded within DN practice?

What are the barriers and opportunities? Drawing on the evidence base, how can we make sense of these? And as a DN team leader, how can this be embedded organisationally and culturally within teams?

Students will be required to consider the impact of relevant policies on community nursing, service users, carers and

person-centred care.

Formative Assessment: Students will have an opportunity to receive feedback from peers and academic staff on a draft assignment plan. This will take place during a dedicated assignment support session when students can discuss and receive feedback on their assignment plan.
