Part 2: Description

Overview: A Continuing Professional Development Module focussing on relation of theory to practise, in the understanding and management of key systems of the clinical patient and aspects of Intensive/Critical care.

Features: Module Entry Requirements: Registered health care practitioner with appropriate relevant experience. Working in a critical care facility (level 2 or 3 critical care dependency).

Educational aims: This module will provide students with the opportunity to enhance their knowledge around key systems of the body linked to critical care as well as holistic care of the patient and family. Additionally, key skills of communication, professionalism and leadership will be focussed on.

Outline syllabus: The syllabus will typically include:

Assessment, management and delivery of care for the following critical care patients (dependency level 2 or 3) in line with the National Competency Framework for Adult Critical Care Nurses (2012) Steps 2 and 3:

- Respiratory System
- Cardiovascular System
- Renal system
- Gastrointestinal System
- Neurological System
- End of Life Care
- Inter & Intra Hospital Transfer
- Rehabilitation
- Professionalism
- Leadership

Evidence based practice:

Tools for searching and selecting evidence from a range of sources

Organisational / political influences on care:

- Current initiatives which impact on practice
- Ethical frameworks within critical care
- Organisational changes and new ways of working

Part 3: Teaching and learning methods

Teaching and learning methods: This module is a professional practice module with learning taking place on campus and in the students own work place, through

clinical supervision with a named mentor, and sign off of national STEPS competencies 2 & 3.

Additional lectures, seminars and simulation sessions (50% of on campus time) will be delivered using a face to face learning approach (on campus only), utilising:
