## Part 3: Teaching and learning methods

**Teaching and learning methods:** Independent learning underpins the teaching and learning strategy on the dissertation module. The student has an identified dissertation supervisor and supervision includes contact hours with the supervisor and formative feedback on draft work.

Students are allocated a supervisor who has the main responsibility for co-ordinating formal support, monitoring progress and project supervision. It is the student's responsibility to initiate and maintain contact with the supervisor. Students undertaking projects requiring NRES (National research ethics service) applications may require extra support which will be negotiated with the module leader and the supervisor.
