#### Part 4: Assessment

**Assessment strategy:** Assessment Task: Defended Poster Presentation (15 minutes total, to include 10 minutes of professional discussion)

This assessment will take the form of a poster and discussion based around risk and hazard management and patient safety. This will include 5 minutes to present the poster and then a 10 minute professional discussion. This assessment method allows assessment of responses where there are a range of potential answers that cannot be tested through the poster delivery. It allows for assessment of knowledge, skills and behaviours that do not occur on a predictable or regular basis. A

professional discussion is a well-recognised method of checking knowledge, skills and behaviours and is widely used within the health sector, and for those completing an apprenticeship, it enables learners to develop and build skills necessary for completion of the End Point Assessment.

Formative Assessment Opportunities: These may include a range of in-class and directed study activities eg informal class discussions and presentations. Poster preparation workshops may be offered.
