Definitions of sustainability: from very weak to very strong sustainability, ecosystems and issues of climate change, system degradation, assimilative capacity, threshold effects, biodiversity and resource depletion. Approaches to valuing the environment.

Frameworks for analysing impact: intergenerational and intragenerational equity, economic growth and the Environmental Kuznets Curve.

Mission, targets and KPIs Carbon Accounting, foot-printing and Life Cycle Analysis.

Social inclusion and equal opportunities Business, family and community.

Fair dealing: relational contracting and the stakeholder model Bad business: from professional crime to managerial self interest The danger signs: information asymmetry, principal-agent problems, opportunism moral hazard and adverse selection.

# Part 3: Teaching and learning methods

**Teaching and learning methods:** Module delivery will be based on 3 hours of scheduled learning and teaching activities per teaching week. This will consist of an alternating pattern of a 2 hour lecture and one lectorial. Lectures will focus on core material, with a particular focus on theory and its application. Seminars will focus on investigating and practising the lecture material; and will involve a mixture of tutorials, group presentations and practical classes.

In addition staff will be available during the semester during their office hours (2 hours a week) for face to face meetings.

Page 3 of 8 01 June 2023 Extensive use will be made of Blackboard for weekly guided independent study work; to support students' learning; to facilitate interactions between students and to provide feedback.
