Educational aims: The module begins with an introduction to the debate regarding globalisation and flexibility on the one hand and employment protection rights on the other hand. This involves consideration of workers' aspirations, needs and responses to these changes in the pattern of employment relationships. This is

developed by identifying the diversity in employment relationships and by focusing on atypical contracts. These discussions are set in an international and comparative context.

Outline syllabus: The following is a list of topics which will be explored in the seminars. The emphasis may shift where there is a shift in relative importance. The list has been drawn broadly enough so that developments in the area can be taken into account.

Overview of Employment law in an international and comparative context considering strands which link in with issues of globalisation and flexibility on the one hand and protection and rights on the other hand.

Employment relationships with a consideration of employment status

Employment protection on termination of the contract

Human rights at work including issues of migration and sustainable development

Particular rights for those involved in flexible types of working (temporary and parttime working)

A review of the issues taking into account different types of economy and sustainable development

Part 3: Teaching and learning methods

Teaching and learning methods: The main focus of teaching and learning on the taught LLM programme is through independent research and debate in the context of 2-hour fortnightly workshops. The workshop-based approach to teaching and learning is designed to enable the student to develop the independent research, analytical and reflective skills required for successful completion of a postgraduate level course. Students will need to complete the necessary preparatory reading and

study of any set case materials in advance of each workshop. For some workshops, students will prepare presentations on a topic explored in the preceding week's workshop: this allows the student to present on the topic by reference to the law of their own or some other jurisdiction, developing understanding in an international and comparative context From each workshop, the student will be expected to have developed a general mastery of the subject under consideration. In addition, students will be expected to raise, critically assess and defend different points of view on controversial issues in class and to make presentations to the class on their own and in groups.
