## **Part 2: Description**

### **Overview:**

The Dissertation is a self-directed learning experience that provides the opportunity for students to evaluate, reflect upon and research a complex public health issue, problem, practice or intervention. It builds upon learning acquired from the taught MSc Public Health curriculum, allowing students to integrate and apply their knowledge and understanding and demonstrate exploratory, analytical,

organisational and communication skills. The Dissertation is an enquiry-based project that utilises investigative, research or evaluation methodologies students have learnt from the taught public health curriculum.

**Features:**

Independent, self-directed project

Utilises primary or secondary research or evaluation methodologies

Integrates learning from the MSc Public Health curriculum

**Educational aims:**

To introduce students to designing, managing and executing a research or evaluation project within a limited time frame

To learn about how to search for, synthesise, critically appraise and interpret a comprehensive body of literature relevant to a specific research or evaluation problem.

To demonstrate practical skills in applying a relevant research or evaluation methodology and methods.

To show understanding of research quality and rigour, applying appropriate critical appraisal and quality techniques to a research design.

To maintain legal and ethical standards of research practice, demonstrating knowledge, understanding and, where applicable, adherence to research governance, ethics and data management regulations.

To display academic writing skills through the production of an appropriately referenced and structured dissertation.

**Outline syllabus:**

One-to-one supervision is provided by an academic supervisor for the duration of the dissertation. The supervisor provides guidance and coaching to support the student in initiating and managing their self-directed project, and specifically in developing their project management skills, creating a research question, developing project aims and objectives, advanced literature searching, methodology and design, navigating ethical and governance requirements, and communication through writing and presentation skills. Students can draw from a range of investigative, research and evaluation methodologies that include primary and secondary quantitative, qualitative and mixed methods, and secondary evidence synthesis (e.g. systematic review, meta-ethnography, realist synthesis, scoping review).

## Part 3: Teaching and learning methods

### Teaching and learning methods:

The module is supported by group tutorials early on in the module, self-directed online learning resources and one-to-one academic supervision throughout the module. Academic supervision is guided by a set of principles and a supervision contract agreed between student and supervisor on commencement of the dissertation project.

## **Part 4: Assessment**

### **Assessment strategy:**

The assessment for this module is as follows:

Component A: 15,000 dissertation

This module is assessed by completion of a summative dissertation that is submitted on completion of an integrative project. Students undertake a project utilising investigative, evaluation or research project skills and a selected methodological approach.

The purpose of this assignment is to provide the opportunity for students to evaluate, reflect upon and research a complex public health issue, problem or practice. It builds upon learning acquired from the taught MSc Public Health curriculum, allowing students to integrate and apply their knowledge and understanding of research and evaluation and to demonstrate exploratory, reflective, analytical, organisational and communication skills.

The module is supported by a series of formative stages. The Research and Project Management Skills module operates as a key planning and review stage for the dissertation project when students develop their project idea into a proposal through a sequence of supportive, interactive action learning workshops. For the full duration of the dissertation, students are allocated a supervisor who guides them through the developmental stages of their project through to final submission. These stages include finessing the research proposal, providing guidance, proofreading and sign-off on research governance processes, reviewing and commenting on draft chapters and maintaining regular monthly supervision and commentary on their progress. Students have access to published dissertations via the electronic library and scheduled and pre-recorded skills workshops on literature searching, data management and data analysis. This assignment enables students to demonstrate

autonomy and to integrate learning from across the master's programme and to apply this to a real world public health phenomenon.
