Part 2: Description

Overview: This module is the start of your journey to developing your professional social work practice. The module introduces you to central ideas and concepts related to professional social work practice and identity.

Features: Not applicable

Educational aims: Studying this module will support you to develop your understanding of professional social work practice. You will participate in simulated

learning of practice skills and a placement observation experience to support your knowledge and skill development.

Outline syllabus: In this module you will start to understand the role of the social worker and to learn about the key elements of professional social work identify.

You will examine the contribution of social work as a professional role with its associated codes of conduct, professional standards, ethics and values. These components are the essential foundation to your future practice.

Your learning will also enable you to identify the range of contexts within which social work practice takes place, including a focus on the value of diversity, and the involvement of people with lived experience in the provision of services.

Your study will include the identification and development of particular knowledge and skills for social work practice across a range of practice settings. For example, communication skills, assessment techniques, confidentiality, the use of supervision, working with other agencies, record keeping and report writing. All this will support you to maintain professional relationships and ensure the role of a social worker is understood.

In this module the United Nations Sustainability Development Goals (SDG) '1. No Poverty' and '11. Sustainable Cities & Communities' will be considered.

Studying this module will help you meet the requirements of all nine domains of the social work Professional Capabilities Framework.

The scheduled teaching and learning will also count towards the 30 days of skills development required by Social Work England.

Teaching and learning methods: Teaching and learning will take place through a

variety of sessions, such as lectures, seminars and workshops which may be held in

person or online. There will be contributions from people with lived experience and

current social work practitioners. You will take part in simulated learning events that

let you develop your practice skills. You will have access to a range of online

resources to support your independent study.

The module also includes an observational placement with a social care agency.

This will give you the opportunity to learn and develop your understanding of social

work practice.
