<b>Assessment Strategy</b>	<p>Assessment of knowledge and understanding is through a variety of formative and summative means in accordance with professional body requirements and industry expectations. Students are assessed both on their practical skills and their underpinning knowledge. The practical examination is focused on the specific skills required for Sports Therapy accreditation such as mobilisation techniques for peripheral joints and will be conducted on a one-to-one basis on a continuous basis throughout the module. As well as being assessed on their practical skills, students will also be questioned throughout the examination. Students' underpinning knowledge of these techniques will be assessed by the written examination.</p> <p>Formative feedback and guidance can be gained in the module delivery, on the VLE, in tutorials and in revision sessions. Summative feedback can be gained on examination scripts and on the VLE.</p> <p>In line with the College's commitment to facilitating equal opportunities, a student may apply for alternative means of assessment if appropriate.
