Teaching and Learning Methods	 Scheduled learning There will be no scheduled learning for this module delivered by the Associate Faculty, Hartpury College. However, it is expected that as part of an Exchange Programme students will be exposed to a range of delivery methods as part of their international study, such as lectures, seminars, tutorials, project supervision, demonstration, practical classes and workshops; fieldwork; external visits; work based learning; supervised time in studio/workshop. Independent learning Students will be expected to prepare for the modules undertaken as part of an Exchange Programme prior to and following attendance at scheduled sessions. This independent study will include hours engaged with essential reading, directed reading, assignment preparation and completion etc. These sessions constitute an average time per level as indicated in the table below.
