Teaching and Learning Methods	<p><i>Scheduled learning</i> There will be no scheduled learning for this module delivered by the Associate Faculty, Hartpury College. However, it is expected that as part of an Exchange Programme students will be exposed to a range of delivery methods as part of their international study, such as lectures, seminars, tutorials, project supervision, demonstration, practical classes and workshops; fieldwork; external visits; work based learning; supervised time in studio/workshop.</p> <p><i>Independent learning</i> Students will be expected to prepare for the modules undertaken as part of an Exchange Programme prior to and following attendance at scheduled sessions. This independent study will include hours engaged with essential reading, directed reading, assignment preparation and completion etc. These sessions constitute an average time per level as indicated in the table below.</p> <p><i>Placement Learning</i> This module, which can form part of an Exchange Programme, requires students to undertake an approved and agreed period (one/two semesters) of overseas study at a higher education institute and on modules appropriate to their programme aims and which have been pre-approved by the Programme Manager.</p>

Assessment Strategy	<p>The module will be formally assessed an oral presentation and a portfolio to evidence the students' academic and personal development. The oral presentation will be held following the students return to the UK, or Skyped as appropriate, and will be an opportunity for students to evidence both their personal development and their subject based development through presentation of their undertakings and achievements and subsequent questioning.</p> <p>During their international study period, students will be required to compile a progressive portfolio to evidence and evaluate the academic study they have undertaken as part of their international study period. This will enable the students and supporting academic staff to ensure that the learning outcomes and the aims of the degree programme on which the student is registered are being met by the modules being undertaken at the partner institute.</p> <p>Formative feedback can be gained from this module through the VLE, and through the progressive portfolio submissions.
