Assessment Strategy	Strategy: Integration of theory and practice is an essential part of this module, both aspects are requirements for the module assessment. Placement experiences will be evidenced within the e –portfolio using the continuous practice assessment. Equity and parity will be achieved as students will have similar 'scenarios' and will have an opportunity to perform a formative assessment where documented feedback will be available.
