Part 3: Teaching and learning methods

Page 3 of 8 26 June 2023 **Teaching and learning methods:** 72 hours made up of lectures, and workshops. There will also be 2 Revision sessions in each teaching block.

The workshop-based approach to teaching and learning is designed to enable the student to develop the independent research and analytical skills required for successful completion of a Level 3 Module.

The content of the course will take full account of issues relating to equality, diversity and inclusion, in line with the strategic directive of UWE.

Scheduled Learning:

Lectorial: Outline learning materials will be supplied to students in advance of the lectorial. Guest speakers will be utilised where appropriate.

Workshops: Workshops will involve problem-solving and the analysis and synthesis of conceptual and contextual issues, through group work, plenary discussion and debate, utilising technology.

Directed reading will be outlined along with a diverse range of sources, as appropriate. Students are expected to make full use of their independent learning time to reflect critically upon the subject and to develop their own ideas.

Part 4: Assessment

Assessment strategy: Assessment Task 1 -online examination to be completed within a 24 hour window - 2500 words (50% of module mark)

Assessment Task 2 – 2500 word Essay (50% of module mark):

Students are given two pieces of coursework to complete during the module, of which they must complete at least one. The mark awarded for the coursework is the better of the two marks achieved.

Students are given detailed written feedback on their coursework – the feedback on the first piece affording them advice on improvement should they choose to submit a second piece.

During the workshops, in which students consider the types of problems and questions which they later encounter in the assessments, students are given oral feedback on their contributions and guidance on their approach.

Students are assessed in both the coursework and the examination against standard criteria: subject knowledge and understanding, analysis and evaluation, communication and literacy, and research and organisation.

The design of the assessment will allow for timely and comprehensive feedback to be given to students; enabling students to apply the feedback to future learning and assessments.

Assessment criteria and grading schemes will be clearly communicated to students and the module team will encourage students to engage with the documents prior to submitting their work.

The assessment will develop a student's understanding of the academic practice of Criminal Justice. The range of assessment offered will minimise opportunities to plagiarise.
