Outline syllabus: The module explores the different ways in which realism in cinema is understood. While documentary has been thought of as the primary site

for the representation of actual events, a number of movements and stylistic trends have tried to achieve the same results in fiction films. Both documentary and fiction have claimed over the years to faithfully represent reality. The module introduces different documentary practices and approaches in fiction films that problematise the assumption of a direct and objective recording of reality (for example performative documentary, Cinema Verité, first person documentary, Neorealism or Free Cinema) and suggests some of the ways in which the representation of reality is constructed through a negotiation between the filmmaker, the camera and the audience perception and understanding of the image.
