Overview: This first-year module is an introduction to British history in the early

modern period.

Outline syllabus: Students consider political, social, cultural, religious and colonial

history in Britain from the Reformation to the first Jacobite Rebellion. Taking a broad

geographical and chronological view, the course considers the interwoven and often

contentious histories of England, Wales, Ireland and Scotland, and students will

explore both specific events and thematic topics in weekly sessions.

Part 3: Teaching and learning methods

**Teaching and learning methods:** The module will be delivered through a

combination of lectures and seminars. Although the module is clearly content-driven

students will be encouraged to think carefully about the sources historians use to

construct their arguments and the way in which academic debate is constructed from

such sources. Lectures will provide an outline of each topic and provide some

contextual background for the seminars. Seminar sessions will use a combination of

selected primary source material from the period (e.g. textual, visual, oral, material),

and selections of secondary literature, and students will have the opportunity to

discuss and debate issues arising from these readings.

#### Part 4: Assessment

**Assessment strategy:** The module is assessed through a journal article review (1,800 words), and a 500 word short written exercise. These assessments are designed to test a range of abilities from critical evaluation of academic literature to the clear and concise communication of ideas, and to develop essential skills for the study of history at levels 2 and 3.

For the journal article review, students are required to select one set of paired articles from the designated titles and critically evaluate the content and argument of each. For the portfolio, students will be required to complete a 500 word written exercise.

The assessments are designed to measure:

- a) critical understanding of concepts and topics relating to British history, as explored in the module
- b) the ability to understand and critically assess journal literature
- c) the ability to present ideas in clear prose and observe appropriate academic standards (footnotes, bibliographies)

The transition from A Level to first year undergraduate study can be a steep learning curve, as students have to adjust to new methods of learning and discussing their learning with their peers. This module is designed to provide an introduction to some of the key teaching and learning methods within the undergraduate History degree. It acclimatises students chronologically by providing an overview of the period,

provides them with a grounding in secondary research critique, and introduces primary material into seminar discussions. As an introduction to academic practice, it will develop their critical reading skills via the seminar reading reports, which will build their confidence in relation to the essay assessment at the end of the course. There will be opportunities for feedback on their work that will enable them to improve for that assessment. The students will be introduced to seminar practice and discussion, and how to read critically for those activities.

Feedback for these assessments will be sent first to students electronically. All students will be invited to attend personal feedback tutorials which will be a timetabled part of the module's contact hours.
