Educational aims: Within this module students will understand the roles and responsibilities of various agencies including Civil Contingency Act, Health and

Safety and COSH regulations.

Module Specification

Outline syllabus: The module will also look at how different parts of the uniformed and public services will respond (a multi-agency response), deal and act with a critical incident as well as well as how it impacts on the local communities, evaluating the lessons learnt from the incident. You will explore a number of case studies as well as being exposed to industry experts as well as table top exercises.

In particular students will cover:

Emergency planning and responsibility of agencies such Police, Fire, Local Authority and Ambulance Services (Responders 1 and 2) under the Civil Contingency Act (2004)

Understand and evaluate command, control, co-ordination and communications of responders 1 and 2 at a major incident.

Explore major incidents and their reviews and analyse the impacts that these have had on current policies and procedures.

Explore the impact of major incidents on both the community and human behaviour.
