Part 2: Description

Overview: A research module that asks students to undertake a small-scale independent research project, tailored to their individual Agenda of personal, learning, creative practice and future career goals. Two pathways are offered. The first enables students with an interest in enterprise and entrepreneurial activity to research into an aspect of creative business. The second enables students with an

Page 2 of 6 22 June 2023 interest in academic research to undertake research and analysis in the field of Animation Studies.

Features: Two teaching intensives cover the essential syllabus for both pathways to enable students to make an informed choice; Students have the option to deliver their work in a form most relevant to their Agenda.

Educational aims: The aim of this module is to inspire students to engage with a focussed research question relevant to their Agenda and assist them to undertake a short investigation that will enable them to learn as a practitioner-researcher.

Outline syllabus: Key concepts in enterprise and entrepreneurial practice; animation industry and business; key concepts in animation studies, film production studies and visual culture; diverse case studies, from multi-cultural contexts; being a practitioner-researcher: identifying connections between topics, theory and practice; practice-led research methods, reportage, picture research and research ethics; practical skills for developing and presenting an academic essay

Part 3: Teaching and learning methods

Teaching and learning methods: Lectures and seminars will enable students to generate and question ideas, think discursively and utilize research methods. Formative assessments, e.g. poster presentations seminars, will enable students to synthesise and focus their enquiry and research question as well as focus and strengthen their arguments and proposals. All students will be allocated a pathway specialist tutor who will offer supervisory support and expertise. Essay tutorials will use the Oxford system. The Library will offer research workshops. Independent research and study form a substantial part of the activity of this module. Academic skills support, including subject-specific and generic workshops and online resources, is available from the Library. Academic skills support for international students is available from the Academic Learning Development team.

Part 4: Assessment

Assessment strategy: The assessment is designed to demonstrate students' ability undertake a small-scale research study in line with their stated aims. The module handbook will give detailed guidance in relation to written assignments, academic probity and plagiarism.

There are two formative assessments: a poster presentation, where students propose what they are going to do and why and a draft outline / plan. Feedback (verbal and/or in writing) from tutors will provide students with a clear understanding

The assessment type has been chosen to enable students to demonstrate achievement across all the learning outcomes of the module and to provide flexibility in selecting appropriate and specific outputs. Students are assessed by criteria and achievement standards that are identified within module handbooks, and individual assignments and briefs. The assessment criteria take account of the quality of the research question; the level of ability to develop, critically and contextually analyse, communicate, present it; the level of professional practice.
