Part 2: Description
<p>Overview: Learners will develop their policing practice with a deeper understanding of the National Policing Curriculum Learning Areas, including valuing difference and inclusion, decision making, evidence-based policing, and coaching, mentoring, and assessment skills.</p> <p>Educational Aims:</p> <ol style="list-style-type: none"> 1. To understand the theories and concepts linked to an evidence-based approach to policing, integrating the code of ethics in their practice. 2. To develop learners' leadership, team-working, coaching and mentoring skills in an operational context. 3. To improve professional practice with further study across key policing areas; response policing, community policing, policing the roads, and information and intelligence. <p>Outline Syllabus: This module will build upon learners' existing knowledge from the Legislation, Powers and Policy, and Policing Skills and Procedures modules, developing a deeper understanding of the theories and principles of modern policing. The module is aligned to the National Policing Curriculum (NPC, see Developing Policing Practices appendix 1), and the module learning outcomes reflect the overarching content of the NPC detailed.</p> <p>Learners will cover the strategic role of the College of Policing and their own role as</p>

professionals; able to demonstrate an inclusive approach to policing diverse communities and upholding the highest standards. The role of regulatory bodies will be explored, and lessons learnt from past experiences examined.

The module will focus on developing an evidence-based approach to practice, using research to analyse 'what works', and how they can improve their own policing practices with an understanding of how this impacts their professional decision-making.

Learners will examine models of communication, organisational culture, leadership, team-working, and how they can become skilled coaches and mentors to fellow officers.

The module will build upon previous learning on terrorism in the first year 'Policing Skills and Procedures' module, examining the national counter-terrorism structure and insider threats. Learners will also critically assess the criminal justice strategies being used to reduce re-offending rates. The module will analyse the distrust some communities feel towards the police, high-profile cases where confrontation has taken place, and the community engagement strategies they can employ.

Learners will critically explore how criminal activity facilitated by the road network can be disrupted, further legislation governing driver rules and regulations, and the policing of major and critical incidents.

The module will equip learners to critically evaluate policing practice to make them effective professionals, policing to the highest standards.

Teaching and Learning Methods: A variety of face-to-face and distance learning methodologies will be employed, including lectures, seminars, case-studies, web-based learning and independent study. Learners will be encouraged to use their previous policing experiences to reflect on their approach to practice.

Part 3: Assessment

Component A:

This module will be assessed through a 3,000 word written reflection on their policing practice.

Rationale:

This will assess students' ability to critically reflect on their practice, and how to incorporate an evidence-based approach to policing.

Formative assessment will take place throughout the programme; learners will engage in activities and peer assessment that will help them to structure their summative reflection, and receive feedback and support from other learners and staff.
