## Part 2: Description

**Overview:** This is a 15-credit professional practice module made up of one 6 week practice placement.

**Features:** Not applicable

**Educational aims:** The student is given the opportunity to further develop their theory and practice skills, building on their first placement experience in level 4.

**Outline syllabus:** Students are expected to develop further their skills in the management and prioritisation of workload and demonstrate some knowledge of evidence-based practice on which their choice of physiotherapy management strategies for individuals is justified.

### **Part 3: Teaching and learning methods**

**Teaching and learning methods:** This module comprises a six week practice placement. Aims and goals will be agreed between the student and the practice educator at the start of the placement.

Teaching and learning will typically include direct clinical experience, observed practice, in-service training sessions, and peer learning where possible.

Self-directed study will also be included, and some placements may allocate time during placement hours to focus on projects or similar tasks.

### **Part 4: Assessment**

**Assessment strategy:** The assessment for this module is based on the students' performance on practice placement, against the module learning outcome and practice placement outcomes, and is done through a continuous practice assessment.

Component A – Continuous Practice Assessment.

This component includes two sections: safety and professionalism. Students are assessed continuously throughout the placement by the practice educator through observed practice and must meet the minimum required standard for each section to pass the placement overall.

Component B – Grading of Practice.

This component includes four sections: communication, clinical reasoning, practical skills and organisation/learning behaviour. Students are assessed continuously throughout the placement by the practice educator through observed practice, discussions, presentation and self-directed work. A mark of 40% or more in each section is required to demonstrate the required level of professional competency to pass the placement overall.

Formative Assessment

Formative assessment and feedback are provided regularly throughout the placement by the practice educator. This happens informally following observed practice (verbal and possibly written) and at a weekly feedback session (verbal and possibly written), and formally at the midway and final appraisals (verbal and written).

A minimum of 150 hours must be completed on the placement to be assessed. If the minimum is not reached, this is classed as a non-submission, and a further placement is required. This will normally be 6 weeks.

If the placement is failed, a 4 week resit placement is required.

A Continuous Practice Assessment form covering both components is completed, signed and dated by the practice educator, and submitted by the student.
