Part 2: Description

Overview: This is a 15 credit professional practice module made up of two 6 week practice placements. Practice placement hours for a 6 week placement are 225, based on the normal 37.5 hour week for most Physiotherapists; and this will contribute to the recommendation by the Chartered Society of Physiotherapy that students complete a minimum of 1000 hours clinical placement.

Educational aims: The student is given the opportunity to further develop their theory and practice skills, building on their placement experience in level 5. Students are expected to develop further their skills in the management and prioritisation of workload and demonstrate knowledge of evidence-based practice on which their choice of physiotherapy management strategies for individuals is justified.

Outline syllabus: The student is given the opportunity to further develop their theory and practice skills, building on their placement experience in level 5. Students are expected to develop further their skills in the management and prioritisation of workload and demonstrate knowledge of evidence-based practice on which their choice of physiotherapy management strategies for individuals is justified.

Part 3: Teaching and learning methods

Teaching and learning methods: This is a 15 credit professional practice module made up of two 6 week practice placements. Practice placement hours for a 6 week placement are 225, based on the normal 37.5 hour week for most Physiotherapists; and this will contribute to the recommendation by the Chartered Society of Physiotherapy that students complete a minimum of 1000 hours clinical placement.

This module will also include teaching sessions to cover mandatory training updates (e.g. Basic Life Support, Manual Handling) and placement preparation.

Part 4: Assessment

Assessment strategy: The assessment for this module is based on the students' performance on both practice placements against the module learning outcome and practice placement outcomes. The assessment for the two placements is identical.

Component A – Continuous Practice Assessment (CPA)

This component is divided into two elements - element 1 assessing placement 3a, element 2 assessing placement 3b. Both use a CPA assessment. It includes two sections: safety and professionalism. Students are assessed continuously throughout the placement by the practice educator through observed practice, and must meet the minimum required standard for each section to pass the placement overall.

Component B – Grading of Practice

This component is divided into two elements - element 1 assessing placement 3a, and element 2 assessing placement 3b. Both use a Grading of Practice. It includes four sections: communication, clinical reasoning, practical skills and organisation/learning behaviour. Students are assessed continuously throughout the placement by the practice educator against the practice placement outcomes, through observed practice, discussions, presentation and self-directed work. A mark of 40% or more in each section is required to demonstrate the required level of professional competency to pass the placement overall.

Formative Assessment

Formative assessment and feedback is provided regularly throughout the placement by the practice educator. This happens informally following observed practice (verbal and/or written) and at a weekly feedback session (verbal and/or written), as well as formally at the midway and final appraisals (verbal and written).

A minimum of 150 hours must be completed on each of the two placements to be assessed. If the minimum is not reached, this is classed as a non-submission, and a further placement is required. This will normally be 6 weeks.

If either of the two placements are failed, a 4 week resit placement is required.

A Continuous Practice Assessment form covering both components is completed, signed and dated by the practice educator for each placement, and submitted by the student.
