#### Part 2: Description

The FdSc Nursing Associate Programme has been developed to provide an outcome based programme of academic and work-based learning that will develop the wide-ranging skills and capabilities required to support the role of the registered nurse. The programme is aligned with the requirements for the Institute for Apprenticeships & Technical Education level 5 nursing associate apprenticeship standard (see appendix 1).

The programme will meet the required professional standards as stated within the Nursing and Midwifery Council (NMC) Standards of proficiency for nursing associates (2018). Students will be supported in accordance with Part 2: Standards for student supervision and assessment (NMC 2018) and the programme has been guided by and mapped against the Nursing Midwifery Council (NMC) standards of proficiency for nursing associates (2018).

Initial assessment of the student's ability in relation to Math, English and Digital Literacy provides a point of reference of their competency. It identifies areas that may need a focus and where further support can be identified to monitor their progression during this programme.

The programme builds on the traditions, experience and values of a nursing profession that looks to the provision of the highest quality, evidence based person-centered care in the 21st century. In a fast-paced world of change, the programme places compassionate care at its core whilst promoting the enthusiastic adoption and promotion of those technologies and innovations that support improvements in patient care and service improvement.

The programme is aimed at those individuals currently working in health and social care, enabling them to have opportunities to progress and develop their careers. They will work under the leadership and direction of registered nurses providing and monitoring high quality holistic and person-centered care to individuals whilst supporting the registered nurse in the assessment, planning, implementation and evaluation of care. The programme aims to produce compassionate, competent and confident nursing associates at academic level 5, qualified to deliver a wide range of clinical care and inter-personal skills, underpinned by a systematic knowledge base. They will be able to practice safely and effectively within their parameters of practice, demonstrating appropriate values and behaviors in a wide range of health and care settings across the lifespan.

The programme is a collaborative development with clinical partners in meeting both local and national demands of the health care workforce to meet patients' needs and expectations now and in the future; with employability and enterprise skills development integral to the programme. Through working in partnership with our local National Health Service partners, and private and voluntary sector partners, the student will be able to experience the range of health and social care that will prepare them for their role. On successful completion of the programme nursing associates can be employed across a variety of health and social care settings without being confined to one geographical area. The nursing associate will be employed throughout the programme within an NHS provider or a private or voluntary organisation.

On completion of the programme the student will be eligible to apply for registration with the Nursing and Midwifery Council (2018) as a Nursing Associate. Progression can *either* be onto the BSc (Hons) Health and Social Care to top up to a Degree, or to progress in Nursing on to the UWE BSc (Hons) pre-registration nursing programme at an advanced entry point.

The curriculum is designed to facilitate the growth of the nursing associate's knowledge, skills and the demonstration of professional attitudes and values required of this role. Each module considers the lifespan and includes the four fields of nursing. Themed days throughout the programme each have a focus on a field of nursing, and this helps the student to explore different aspects and approaches to care. Service user involvement is fundamental in these days. Elective days will be organised by the students to maximise the opportunities to expand their own knowledge and identify continuous development of practice, to anticipate future trends in health and social care delivery.

The programme has six platforms and 2 annexes with associated learning outcomes that are achieved through both theory and practice experience by the student.

### **Placement experience**

By the end of the programme the nursing associate will have had the opportunity to work with a range of people across the three health settings: in hospital, at home and close to home. This gives an opportunity to experience and demonstrate all the six platforms for safe, effective, compassionate, competent, and non-judgmental care.

#### Uniqueness of placement experience

To facilitate the required placement experience and to enable work with a range of client groups there is a collaboration between clinical partners to offer an innovative placement pattern across all organisations. This will enable the student to follow patients throughout their journey, appreciating the patient's perspective, and reinforcing the patient centered care philosophy of the programme.

Nursing associates will have a practice supervisor and practice assessor throughout their placements. The assessor will have overall responsibility for ensuring that the competencies for the programme are achieved.

Tripartite reviews will be undertaken on a regular basis. This is an opportunity for the nursing associate, employer and academic assessor to discuss progress and action plans for future learning.

Within the programme students are able to access alternative learning experiences through elective day experiences. These are sourced by the student and encourages engagement with health and social care outside of their normal parameters of care.

For those undertaking this programme as an apprenticeship, the practice placement experiences prepare students for the required End Point Assessment.

### Programme requirements for the purposes of the Higher Education Achievement Record (HEAR)

On completion of the programme the nursing associate will be able to demonstrate personal responsibility and work independently within defined parameters of practice, taking the appropriate initiative in a variety of situations, and performing a range of clinical and care skills consistent with the roles, responsibilities and professional values of a nursing associate.
