Page 2 of 7 23 June 2025 **Overview:** The MSc Psychology (Conversion) programme at UWE is an applied, practice-based conversion course that enables graduates from other disciplines to access psychology careers.

The design of the programme is built on the core BPS curriculum covering the theoretical principles of human thought, action and behaviour with a strong emphasis on academic knowledge and its application in real-world contexts.

Features of the programme: The course embeds an integrative focus across its modules, developing skills that will address real-world questions. A values-led approach ensures that inclusivity and equality are central to the learning environment we create. We actively facilitate a diverse approach to learning and teaching, such that expertise is drawn from all walks of life.

Throughout this course, students are encouraged and supported in the application of their skills. Close working relationships with local and national health-based organisations provide multiple avenues for students to develop their skills.

Student mental health is of primary concern throughout this programme; we have embedded mental health initiatives within our curriculum, including peer-led networks, collaborative initiatives with local mental health charities and academic inquiry into health and well-being.

Successful completion meets the requirements for the Graduate Basis for Chartership (GBC), a pre-requisite for Chartered membership of the British Psychological Society.

Educational Aims: The core educational aims of the programme are:

To provide students with an applied, practice-led learning experience that meets the British Psychological Society's requirements for the Graduate Basis for Chartered Membership.

To develop students' understanding of the application of Psychology, alongside and

To create opportunities for students to translate psychological theory, content, and skills into practical solutions within and beyond the sector.

To develop knowledge and understanding of a full repertoire of research skills for independent inquiry into experience and behaviour, embedded within a complex socio-cultural environment.

To create a culture of respect and value for the diversity amongst people and ideas, in line with Psychologists' roles as scientists, practitioners, and advocates.

- PO2. Critically analyse and systematically evaluate knowledge underpinning scientific inquiry and ethics, to facilitate the independent development of hypotheses, research paradigms, methods, and analytical appraisal.
- PO3. Evaluate complex systems from individual humans to groups of people and populations by adopting multiple perspectives in order to systematically appraise the relationships between them.
- PO4. Develop competency and confidence across the psychology research skillset, including ethical procedures, practical laboratory techniques (specialised software, psychometric instruments and paradigms), quantitative and qualitative analytical methods, as well as the implications and limitations of these approaches.

- PO5. Recognise and address real world challenges systematically, creatively and collaboratively. Demonstrating agile, evidence-based reasoning in the presence of uncertainty.
- PO6. Critically analyse the distinctive role of psychology and its relationship to a broader set of disciplinary expertise, which together consider the conditions for human and planetary health. Alongside an acknowledgement, respect, and value for the differences between people, their ideas, and their choices.
- PO7. Apply systems-thinking to cross-disciplinary work, integrating fluent communication with cross-disciplinary specialists, peers, clients, and a lay audience.

Assessment strategy: The Assessment Strategy employed by the MSc Psychology (Conversion) programme has been developed in order to be valid (specific to the learning outcomes), equitable (differentiating amongst students), reliable, and fair. Feedback on assessment throughout the programme is designed to support students' ongoing learning and development.

Learners have different strengths and preferences for assessment methods. Consequently, this programme deliberately utilises a range of alternative assessment approaches, including oral presentations, article critiques, written reports, case study analysis, and quantitative and qualitative lab reports.

The Assessment Strategy has been designed to support and enhance the development of both subject-based and generic key skills to support students in taking their next steps in psychology. The focus is on assessments that link directly to relevant, professional skills as well as assessments for learning discipline content. Assessments are designed to capture both the distinctive features of modules, as well as the ways in which the domains of psychology are fundamentally integrated and applied in a real-world context. This integrative approach to assessment is detailed within each module specification.

Student support: The programme handbook is provided for induction that includes information on the University, its regulations and procedures, on the School of Social Sciences, and is supplemented by more specific module guides. Students are
