Section 2: Educational aims of the programme

The aims of the postgraduate modular scheme are:

- to provide students with the academic foundation, intellectual background, and study skills necessary to pursue programmes of study at advanced level;
- to provide flexible learning opportunities for students wishing to study at postgraduate level;
- to enable students to conduct research appropriate to their abilities and interests, and to develop a creative practice consummate with the aware PGDip/MA;
- to encourage intellectual enquiry, conceptual clarity, innovation, originality and a high level of practical, technical and analytical ability;
- to equip students with the conceptual and critical tools necessary to develop their creative role.

The aims of the MA Fine Art programme are to provide an opportunity for students to:

- develop an advanced understanding of their subject specialism;
- produce, develop and organise work of increasing ambition and quality;
- join the field of contemporary Fine Art practice at a professional level;
- engage in a structured exploration of methods appropriate to the field;
- sustain an independent professional practice;
- develop an in-depth critical awareness of the professional field of fine art studio practice.

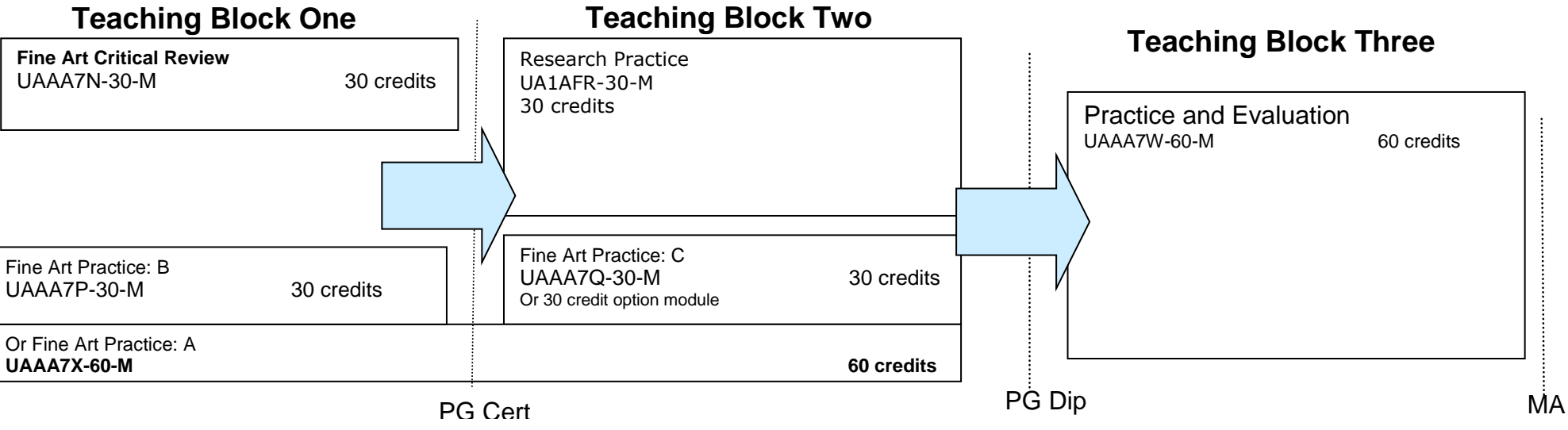

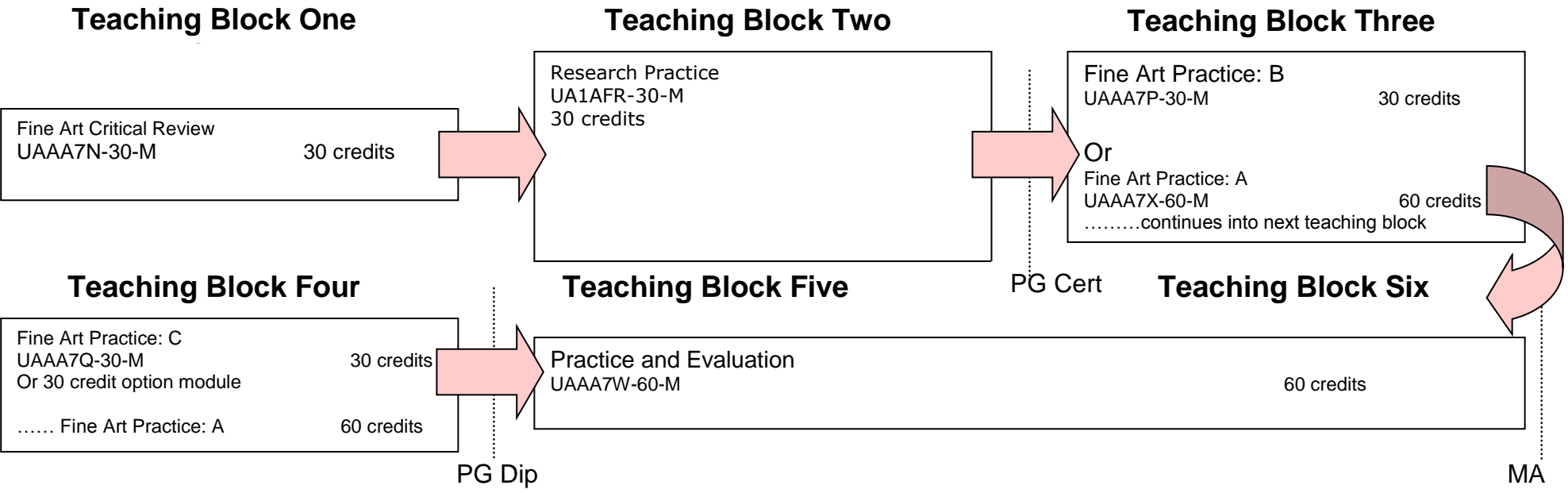

Section 5: Entry requirements

All applicants will be interviewed as long as their application indicates that they have had sufficient prior experience. This should normally include a first class or upper second degree with honours, an equivalent qualification or equivalent professional experience. The pathway cannot recruit students with no prior fine art experience and students must be able to demonstrate enthusiasm for the subject and be capable of articulating how the programme may enhance their practice. The interview will focus on the applicant's interest in Fine Art and their understanding of the demands of an MA programme.

The programme will be taught in English and all students will be expected to have obtained an appropriate level of English literacy and comprehension (TOEFL 6.5 or above). The programme places emphasis on an understanding of research and methodology in relation to creative practice and the contextualisation of such a practice within the production process. The programme is demanding in its requirements at each stage and all applicants will be expected to demonstrate that they are both capable and willing to fulfil the demands of the pathway.

The programme aims to support learning through a range of modes of fine art production in which students can develop the practical, intellectual and creative aspects of their practice to a professional level. The programme facilitates engagement between a range of practitioners in order that students are able to locate their practice within contemporary culture. The programme places particular emphasis on a rotating series of group tutorials and critiques which take place in student's studios or work places. Students benefit from a range of specialist visitors (artists, critics, writers, curators) and one or more lecture series and are also expected to make regular visits to exhibitions in London, Bristol and elsewhere.
