Person-Centred Essay 2000 words

This will assess students' understanding of Person-Centred counselling theory (Learning Outcomes A, B and D) and relating this to their practice and self-evaluation (Learning Outcome C)

Portfolio:

The portfolio assesses students' practice in counselling skills, and their capacities as reflective practitioners and their understanding and adherence to working within ethical codes and appropriate boundaries. (Learning outcome C, D and A).

And either: Gestalt Counselling Skills

Gestalt Essay 2000 words This will assess students' understanding of Gestalt counselling theory (Learning Outcomes A, B and D) and relating this to their practice and self-evaluation (Learning Outcome C).

Psychodynamic Counselling Skills

Psychodynamic essay 2000 words

This will assess students' understanding of Psychodynamic counselling theory (Learning Outcomes A, B and D) and relating this to their practice and self-evaluation (Learning Outcome C).

Portfolio:

The portfolio assesses students' practice in counselling skills in their employment or voluntary work, and their self-awareness and personal development over the course. It also their abilities to use supervision to reflect on their practice. (Learning outcome C, D and A).

Assessment of the Learning Outcomes:-

Knowledge and Understanding:

Testing of the knowledge base is through assessed coursework (1&2) and through observation of counselling skills practice and supervision [1-5].

Intellectual Skills:

variety of assessment methods is employed including essays, book reviews, a personal development journal, observation of skills practice and supervision. All test a learner's ability to demonstrate skills 1-4.

Subject, Professional and Practical Skills:

Skills 1, 2, 3 are assessed through skills practice and supervision. Skill 4 is assessed by self, peer and tutor assessments Skills 5, 6, 7 and 8 are assessed through supervision and a self-development journal.

Skills 1-6 are assessed through skills observation, supervision, essays, self and peer assessment, a self- development journal and book reviews.

Student support: There is a continuous programme of workshops which support safe ethical practice and working with diversity. This is monitored continuously through skills observation and periodically through supervision.

Students support one another's emotional development through regular weekly peer support. These sessions also serve as an opportunity for further skills practice.
