Section 2: Programme Overview, Aims and Learning Outcomes

Part A: Programme Overview, Aims and Learning Outcomes

Overview: The Graduate Diploma in Professional Policing Practice is a two year integrated programme, and is licensed by the College of Policing as one of the principal entry routes for police officers. The programme is intellectually stimulating and provides relevant learning experiences with the aim to produce Police Constables and Detective Constables for local forces who are ready and able to realise their full potential and make a positive contribution to their communities, workplaces and society.

The programme has been designed in accordance with the core requirements and national curriculum set by the College of Policing, and the additional requirements for a specialist detective pathway. The UWE programme is fully mapped to meet the requirements of partner forces. A core strength is that the programme will be delivered in collaboration with policing partners, integrating academic study and professional practice. UWE have been successfully delivering policing education since 2019, and this programme will provide a further structure to teach new constables for partner forces.

The programme is designed to be flexible in delivery, enabling partners to specify a focus on response or community policing, or as Detectives. A specialist Detective programme will integrate the requirements for learners to meet the requirements of the Professionalising the Investigations Programme (PIP) level 2, becoming accredited Detectives. Central to this will be the learning required to achieve the National Investigators Examination (NIE), and immersion within a specialist investigations department. Ultimately, a UWE Diploma graduate will be able to apply academic knowledge to real world contexts, and demonstrate the knowledge, skills and behaviours relevant to 21st century policing; amongst these attributes they will be a resilient team worker, strong communicator and ethical decision maker.

The course seeks to embed the following professional education principles that have been identified by the College of Policing as of national importance:

Meeting the professional requirements of 21st Century policing

Ensuring national consistency of professional education

Championing a values-based, ethical approach to policing

Supporting equality of educational opportunity within the policing profession

Developing a high-quality, evidence-based education for the policing profession

Promoting a collaborative approach to education within the police service

Enabling continuing professional development in policing roles.

This will be achieved by using input and expertise from across the department of Health and Social Science, the Faculty of Health and Applied Science, the wider university and colleagues in partnership forces to deliver a vibrant, relevant and multidisciplinary approach to Police education. The policing programme at UWE is informed by a range of research and theory (i.e., incorporating criminology, sociology, psychology, philosophy, forensic and computer sciences, law, public and mental health and social policy among others) to help learners develop a wider critical knowledge base and enable them to make more informed decisions in practice. To assist learners in their operational practice the UWE diploma will utilise an applied approach; situating knowledge development within debates about the role of the police within the criminal justice system, applying this knowledge to police practice as it relates to the 5 key professional areas of policing identified within the Policing Education Qualifications Framework (PEQF), and in accordance with the operational requirements of the employer force. The programme will therefore provide comprehensive, modern and up-to-date coverage of areas of knowledge, skills and professional approaches that have been identified as critical to the 21st century policing role of the constable.

Features of the programme: The Graduate Diploma in Professional Policing Practice provides distinct pathways depending on the requirements of partner forces. Delivery will be focused on the specialist needs of uniformed response and

neighbourhood roles, or as detectives. This will ensure that learning can be framed

within the future role of learners.

The detective pathway integrates the learning required for the PIP 2 programme, and

the additional learning time required to excel in the NIE.

A UWE diploma graduate will be ideally placed to become a specialist in their role,

embedding best practice and an evidence-based approach throughout their careers.

Educational Aims: This programme will:

1.Develop learners' understanding of the legislation, powers and policies central to

their role as a Constable, and to be able to employ these appropriately in their

professional practice.

2.Develop key investigative skills, including creating effective and ethical

investigative strategies, interviewing, case file management and disclosure of

evidence.

Embed a culture of inclusivity and diversity within learning and professional

practice.

4. Enable learners to identify risk and safeguard the vulnerable from harm.

5. Provide an opportunity to critique the criminal justice system using key guidance

and academic theory, helping learners to make confident, appropriate professional

decisions.

Assessment strategy: A range of assessments have been created to meet the educational aims and learning outcomes of the programme and individual modules.

During the first year of the programme you will complete a multiple-choice examination on criminal legislation and policing powers. This assessment is similar in format to assessments you will complete throughout your policing careers, including the National Investigators Examination which you must complete to become Detectives. You will also complete a critical reflection on an incident attended during professional practice, and an assignment evaluating domestic abuse policy. These assessments will ensure that you are able to critically reflect on incidents that you attend, crucial to improving your professional practice.

During the second year of the programme you will complete a written reflection on the development of your practice, and produce either an investigative strategy based upon a simulated case-study or produce a report on issues affecting response or community policing. You will also give a reflective presentation. These assessments are varied, ensuring that the skills and behaviours of officers are assessed in addition to the learning outcomes of the programme.

Assessments are closely linked to professional practice, ensuring that you are able

to successfully demonstrate your ability to become skilled police officers.

Formative assessment will take place throughout each module through peer and class discussions, with activities designed to support you towards your final assessments.

Student support: This course is licensed by the College of Policing, who provide a wide range of support to you through access to online learning materials, authorised professional practice, and the 'What Works' Centre.

Additionally, you will receive the support of an academic personal tutor throughout the programme, and development meetings conducted at regular intervals during your diploma with academic staff and representatives from partner forces. This support will enable any further needs and support to be identified and actioned either by your employer or UWE, highlighting the close relationship between UWE and partner forces.

Part C: Higher Education Achievement Record (HEAR) Synopsis

Graduates of the programme have the knowledge, behaviours and practical skills to be effective and ethical police officers.

Graduates possess an in-depth knowledge of criminal legislation, powers, national and local guidance, and are equipped with the skills to investigate a variety of crimes and incidents, interview suspects and witnesses according to their individual needs, producing high-quality evidence for use in criminal prosecutions.

Learners focused on response policing will have the additional knowledge required to attend incidents in challenging circumstances, while specialist investigators will be

able to investigate serious and complex crimes with a high-degree of autonomy, protecting the most vulnerable members of society.

Part D: External Reference Points and Benchmarks

The Graduate Diploma in Professional Policing Practice is licensed by the College of Policing, who regulate police education in England and Wales.

The learning outcomes and structure of the programme have been mapped to meet the requirements of the Policing Education Qualifications Framework: Degree-Holder Entry Programme (DHEP). Additionally, the programme is designed in accordance with the core requirements of the National Programme Specification, and the additional requirements for the DHEP investigations pathway.

The National Investigators Examination is a key feature of the investigations pathway, and this is integrated within the structure of the first and second year of the programme, in addition to the requirement to achieve Independent Patrol Status (IPS) and Full Operational Competence (FOC). Completing the investigations pathway will see learners meet the criteria to become accredited PIP level 2 investigators.
