### PART A: PROGRAMME OVERVIEW, AIMS and LEARNING OUTCOMES

#### 1. (Programme) Overview (c. 400 words)

The programme will be undertaken by students intending to pursue a career in law and in particular, to qualify as a barrister and be called to the Bar.

The Programme aims to equip graduates with the legal knowledge and skills to succeed with a career in legal practice, by undertaking a programme which has a professional focus (with professional body validation of the modules). The Programme provides progression for a student from their academic legal studies to their vocational stage of training, It provides students with a foundation for legal practice, equipping them with the legal knowledge, skills and commercial understanding to succeed in a career as a barrister; while also preparing them for work-based learning

The Programme offers practice orientated learning with a Teaching & Learning Strategy which focuses on student centered learning. Students prepare for legal practice, both through undertaking the programme, but also by engaging in a range of extracurricular activities. The programme benefits from strong links with the local Bar and Western Circuit.

Students undertake the programme in distinct stages. In Part One they acquire knowledge of the subjects of Civil Litigation and Evidence and Criminal Litigation and Evidence leading to centralised assessments, but also through the application of that knowledge in the skills modules. Having then successfully passed the centralised assessments they then develop their skills (and apply that knowledge) in the skills modules in Part Two.

We provide a professional course that demands students to demonstrate professional attributes in their preparation, attendance and participation in class. It is a rigorous professional post graduate course and therefore the teaching and support needs to be of a high quality to ensure that the students can perform to their fullest potential. The Bar standards Board requires high standards of the students and of the teaching staff providing the course

#### 2. Educational Aims (c. 4-6 aims)

The overarching aims of the Programme are:

- to prepare students of the Inns of Court for pupillage at the Bar of England and Wales
- to enable students of the Inns from overseas jurisdictions to acquire the skills required for pupillage at the Bar of England and Wales, thereby assisting them to undertake further training or practice in their home jurisdiction.

The Specific objectives of the Programme are:

- to bridge the gap between the academic study of law and the practice of law
- to provide the foundation for the development of excellence in advocacy
- to inculcate a professional and ethical approach to practice as a barrister
- to prepare students for the further training to be given in pupillage
- to equip students to perform competently in matters in which they are likely to be briefed during pupillage
- to lay the foundation for future practice, whether in chambers or as an employed barrister, and
- to encourage students to take responsibility for their own professional development

### PART C: HIGHER EDUCATION ACHIEVEMENT RECORD (HEAR) SYNOPSIS

Students acquire the key knowledge and skills sets to equip them for a Professional Law career.

Over the course of their studies, students will transition from being a student in law to a professional lawyer who will graduate with highly developed skills of critical thinking, research and persuasion (both orally and in writing) and who will have a developed a moral compass to navigate the ethical code of practice.

There are numerous opportunities for students to participate in career enhancing activities including chambers sponsored mooting and advocacy competitions, practitioner led advocacy sessions and probono work.

## PART D: EXTERNAL REFERENCE POINTS AND BENCHMARKS

There are no QAA postgraduate law benchmarks.

The program is aligned to the QAA level descriptors and Characteristics for a postgraduate diploma program namely it inculcates students with an in depth and advanced knowledge of the subject and profession to include a critical awareness of current issues and developments in the knowledge modules, the skills necessary for a successful career in professional law, knowledge of professional responsibility, integrity and ethics and the ability to develop as a reflective practitioner. Addiotnally, students will be able to apply research and critical perspectives to a professional law context. Further, students will graduate from this program possessing the skills and experience necessary for a Professional Law practice.

The programme is regulated by the PSRB which has oversight of the curriculum design, content and assessment outcomes. The PSRB monitors the program through receipt of Annual Reflective Reports submitted and through monitoring panel visits, the reports of which are published online. Additionally

external examiners who visit the program to observe teaching and to attend Examination Boards are appointed and report to the PSRB. Data is collated by the PSRB and reports published offering data comparisons across the institutions in terms of matters such as student progress.

Two modules are assessed by way of centrally set assessments. These are authored by a team acting under the auspices of the PSRB.

Program requirements in terms of entry criteria (to include English Language proficiency and successful completion of an aptitude test) attendance regulations and assessment regulations are set by the PSRB.

The program additionally has strong partnership links and connections with the local and regional legal profession; who are actively involved in programme delivery and careers support activities.
