## Section 2: Programme Overview, Aims and Learning Outcomes

## **Part A: Programme Overview, Aims and Learning Outcomes**

**Overview:** UWE's Education provision is founded on a moral purpose to make a difference through deep partnership, by contributing to improvement in a range of educational settings and contexts whilst enhancing approaches to education professionals' continuing development of effective practice.

The international Doctorate key areas of study include prevalent concepts and theoretical models in education and their relationship to practice; a focus on the development of reflective skills and a critical and enquiring approach to theory and practice; the development of leadership skills; and how to carry out robust and ethical research project.

Aimed exclusively at international audiences, key concepts that lie at the heart of the programme design include global perspectives of educational systems, critical analysis of educational theory and practice, advanced research methods and the ability to conduct a longitudinal research project. Throughout the programme students will be required to think critically and demonstrate reflective and reflexive skills both within the literature and their professional context. In developing these skills and ways of approaching their practice they will become more aware of their own role and impact within their context, or develop the skills to project forward to potential working contexts.

The EdD international is split into two stages; the taught element (stage 1) and the thesis (stage 2). Stage one involves the four modules and is delivered both online and face-to-face during the summer school. Students must pass all four modules before they can progress to stage 2. Students will also be supported to complete the research design and ethics requirements to progress to stage 2. Stage 2 will consist of some early taught content during the summer school and 1-2-1 student support through a Director of Study and supervisor and will be online. As students are only required to attend the university in years 1-3, the majority of stage two will be supported through online meetings with the supervisory team. The student and Director of Studies can decide how best to provide evidence of compliance with

UWE Doctoral requirements (PGR2.2.1R) but work must be presented as a thesis of up to 60,000 words.

**Educational Aims:** Consider theoretical and philosophical conceptions of knowledge

To enable students to identify, design, manage, conduct and report on an original research project.

To review, appraise and critically apply relevant literature from the appropriate fields of knowledge.

To develop knowledge and understanding of the field of educational research, and methods and methodologies underlying different methods of empirical or philosophical enquiry.

To critically evaluate and handle the ethical implications of practice and research

Develop knowledge and understanding of a range of current and enduring issues and ideas which impact upon educational research, practice, processes and outcomes, engaging with theoretical frameworks to aid knowledge and understanding.

Support students to engage with wider debates on global perspectives and values in education.

To enable students to appreciate how theory and research apply in practice
